Failure to do so could result in the forfeiture of the Security Deposit, possible criminal charges, and denial of future request for issuance of permit(s).

Alcoholic beverages are to be consumed within the confines of the location on approved permit. Under no circumstance whatsoever are alcoholic beverages to be taken and/or consumed off the Facility. **The open container law is strictly enforced in the Complex and at all Town owned facilities.** Additionally, you are responsible for and subject to NYS Social Host Law. The Town of Saugerties is not liable, in any way, for any alcoholic related incidents and by the placement of your signature, below, Permit Holder understands and agrees, said Permit additionally serves as Hold Harmless Agreement and releases the Town of Saugerties any and all action(s) related to alcoholic beverages and consumption.
