**Resolution- *Reconstruction of Basketball Court at Jaycee Field***

**Whereas**, The Town advertised for bids for Contract TSA-261, Reconstruction of Basketball Court at Jaycee Field; and

**Whereas**, on December 2, 2025 the town received three bids for this Contract, including Base Bid, Bid Alternate and Bid Addition; and

**Whereas**, the engineer, Brinnier and Larios, P.C. reviewed the bids with Mr. Chorvas and made a recommendation to the Town Board on January 5, 2026; and

**Whereas**, Carver Construction. Inc of Albany, NY was the lowest responsible bidder for the combination of Base Bid plus Bid Addition No. 1; and

**Therefore be it resolved**, that Contract TSA-261 be awarded to Carver Construction in the amount of \$116,174.00, said amount includes a \$10,000. contingency allowance; and

**Be it further resolved**, that a credit of \$8,500.00 will be deducted from the Contract with the Town purchasing and delivering the ITEM 4 subbase to the site.
